1 RULES

The races will be governed by the rules as defined in *The Racing Rules of Sailing (RRS)*.

- 1.1. Other rules that will apply are as follows:
 - 1.1.1. IRC rules 2020 Parts A, B and C for boats entered in IRC division
 - 1.1.2. Class Rules for one-design entries and boats sailing under a standard one-design rating.
 - 1.1.3. All ORCi Rating Rules for boats entered in ORCi division.
 - 1.1.4. Prescriptions and Special Regulations of Sailing Australia Inc. (AS), Part 1, Category 5 for all entries.
 - 1.1.5. This Notice of Race and the Sailing Instructions for this regatta.
 - 1.1.6. For the purpose of IRC Rules 2.1.1.5(d) and (e) this regatta is on consecutive days and the sails carried on board shall remain the same.
 - 1.1.7. For IRC rule 22.4.2 shall not apply. Maximum number of crew that may sail aboard a boat shall be the CREW NUMBERS printed on her Certificate plus one. There is no crew weight limit.
 - 1.1.8. RRS 50.2 and 50.3 are amended so that fixed and retractable spinnaker poles and bowsprits are permitted for the purpose of setting asymmetrical spinnakers.
 - 1.1.9. Boats shall not carry anchors protruding from the bow whilst racing.
 - 1.1.10. A minimum of 5 boats is required to constitute a division or class.
 - 1.1.11. Subject to entries, divisions may be revised by the Race Committee.
 - 1.1.12. RRS 55 is amended adding the following sentence to the rule: 'However, discarding cotton, wool or any other biodegradable material when setting a sail is permitted.
- 1.2. Amendments made to this Notice of Race prior to 15th July, 2020 will be published on the event web site [www.scor.com.au], and details of amendments made after that date will be posted on the Regatta Notice Board and may be posted on the web site.

2 ADVERTISING

- 2.1 Boats may be required to display advertising chosen and supplied by the organising authority which may include bow stickers that must be positioned not more than 1 metre aft of the bow.
- 2.2 The Race Committee may reject any advertising that may conflict with the interests of the sponsors of the event.

3 ELIGIBILITY AND ENTRY

- 3.1 Entries are invited for the following Divisions:
 - 3.1.1 IRC (comply with Sailing Australia Special Regulations Part 1 Category 5).
 - 3.1.2 Performance Handicap System (PHS) Rated racing & cruising monohull and multihull boats that comply with Yachting Australia Special Regulations Part 1 Category 5.
 - 3.1.3 Boats entered in IRC division shall hold a current 2020-2021 IRC measurement certificate (copy to be submitted with their entry form).
 - 3.1.4 Boats entered in ORCi divisions shall hold a current 2020-2021 ORCi certificate (copy to be submitted with their entry form).
- 3.2 Divisions may be revised based on numbers of entries.
- 3.3 Entry forms can be found online via the regatta web site: **www.scor.com.au** or please email us and we will forward a copy: **sunshinecoastyachtclub@outlook.com**. See NOR clause 6.
- 3.4 It is the responsibility of each boat to ensure that every member of the crew satisfies the requirements of RRS46.

4 SCHEDULE

- 4.1 IRC and ORCi racing will be a series of up to 6 races conducted over two days; Sat 18th to Sun 19th July, 2020.
- 4.2 PHS and Multis racing will be a series of up to 6 races conducted over two days; Sat 18th to Sun 19th July, 2020.
- 4.3 The first warning signal scheduled will be not before 10:00 on any race day.
- 4.4 No warning signal will be made after 15:30 on the last day of regatta.

5 SAILING INSTRUCTIONS

5.1 The Sailing Instructions will be available on the regatta website: www.scor.com.au com by 1800 hours on Friday 3rd July, 2020. Alternatively, please email us and we will forward a copy: sunshinecoastyachtclub@outlook.com.

6 CERTIFICATION, INSPECTION

- 6.1 Owners [or owner's agents] shall submit to the Sunshine Coast Yacht Club, no later than 1700 hrs on Friday 10th July, 2020 the following documents:
 - 6.1.1 Current Safety Compliance certificate to Category 5 [or better].
 - 6.1.2 Completed entry form.
 - 6.1.3 Current IRC certificate (IRC entrants), current ORCi certificate (ORCi entrants) or current measurement certificate (One Design classes).
 - 6.1.4 Certificate of liability insurance (see NOR clause 14).
 - 6.1.5 Race Entry Fees.

Late entries with valid reason may be accepted at the discretion of the Organising Authority.

7 HANDICAPS

- 7.1 For PHS divisions, handicaps will be allocated according to the speed potential of the individual
- 7.2 Handicaps will be allocated at the sole discretion of the regatta handicapping committee
- 7.3 The handicaps allotted to a yacht shall not be grounds for protest.
- 7.4 Handicaps may be adjusted between races at the discretion of the handicapping committee

8 VENUE

- 8.1 The host club is the Sunshine Coast Yacht Club, 33 Parkyn Parade, Mooloolaba Qld 4557.
- 8.2 Racing will be conducted on the waters to the east of the Mooloolaba River

9 THE COURSES

9.1 The courses to be sailed will be a combination of Windward / Leeward and coastal or passage style courses conducted between Caloundra and Noosa as detailed in the Sailing Instructions.

10 PENALTY SYSTEM

- 10.1 The scoring penalty, rule 44.3, will not apply.
- 10.2 Rule 44.1 is changed so that the Two-Turn penalty is replaced by the One-Turn penalty.

11 SCORING

- 11.1 Three (3) races are required to be completed to constitute a series.
- 11.2 When up to Four (4) races have been completed, a boat's series score will be the total of her race scores.
- 11.3 For all divisions, when Five (5) races or more have been completed, a boat's series score will be the total of her race scores excluding her worst result.

12 LIABILITY

- 12.1 By lodging an entry, the owner/charterer agrees that: -
 - 12.1.1 It is a fundamental condition of entry that he, she or it releases, holds harmless and indemnifies SCYC and its associates, its office bearers, servants, agents and members and the sponsors of SCOR 2020 from all liability any of those persons has to the owner/charterer or any crew member on the owner/charterer's yacht, or to any person claiming through or under any such person arising from loss or damage how so ever caused, including negligent act or omission, arising out of or relating to: participation by the owner/charterer's yacht or any other yacht in a race; the conduct or course of the race in any respect including, without limitation, any act or omission (whether reasonably foreseeable or not) causing or relating to loss of or damage to any yacht or the death or injury of any person; or any of the matters referred to in the paragraphs above.
 - 12.1.2 Participation by the yacht and by the crew in SCOR 2020 is agreed by organising authority on the basis that participation is entirely at the risk of the owner/charterer and each member of the crew on the owner/charterer's yacht.
 - 12.1.3 The owner/charterer will provide each crew member or proposed crew member with a copy of these Conditions of Entry.
- 12.2 All those taking part in these races are reminded of their obligations as set out AS Special Regulations Clause 1.02 "Owner's Responsibility".
- 12.3 Attention is drawn to RRS 3, (Acceptance of the Rules) and RRS 4, (Decision to Race).

13 BERTHING

- 13.1 Free berthing may be available for 17th and 18th July for competing boats at Mooloolaba Marina, SUBJECT TO AVAILABILITY.
- 13.2 Berths may be booked by competitors after entering SCOR 2020 by contacting Mooloolaba Marina Phone: 07 5444 5653 or info@mooloolabamarina.com.au stating that you are an entrant.
- 13.3 Boats not participating in the racing will be charged normal rates.

14 PRIZES AND DIVISIONS

- 14.1 Prizes or trophies will be presented for first, second and third overall in each division, depending on the number of entries.
- 14.2 The winner of the 'Frank Hurd Memorial Trophy' (a perpetual trophy), will be selected by the Frank Hurd Trophy Committee, and will be based on 'performance & character'.
- 14.3 Presentation of trophies will be held after racing on Sunday 19th July.

15 INSURANCE

15.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$10M (recommended \$20M) per incident or the foreign currency equivalent.
